



Suntan Art Center Pass-a-Grille Art Mart Application

Suntan Art Center hosts a juried art market every Saturday, Sunday, in-season Friday's (January-April), and the occasional holiday Monday on the patio in historic Pass-A-Grille. The purpose of this market is to provide local artists with a venue to sell their work and bring the beach community together in a beautiful coastal setting where they can find handmade treasures for home & heart. The market is located on the patio in historic Pass-A-Grille between 9th and 10th Avenues on Gulf Way, next to Paradise Grille and across from Hurricane Seafood Restaurant. To ensure that the work of each vendor is creative, original and well-crafted art, each participant will be juried.

To apply to be a vendor at the Pass-a-Grille Art Market, please return a completed application to suntanart@gmail.com.

Guidelines for Acceptance:

- Original work of all mediums from artists, crafters, and designers will be considered for acceptance.
- Original art work by the artist or reproductions of the artist's original art work will be permitted. Artwork that has been created by another person will not be permitted.
- In order to maintain an eclectic experience for customers, one artist per medium and style will be accepted. Once a category has been filled with the maximum number of participants, the jury will close the category to new vendors.
 - ie: multiple watercolor painters will be admitted with different techniques and subject matter.
 - ie: multiple jewelers will be admitted with different techniques and styles.
 - ie: multiple photographers will be admitted with different techniques and subject matter.
- Vendors are not permitted to add additional product lines (outside the products described on their market application) without market management approval.
- All vendors must be able to provide a 2019 Florida Resale Certificate for Sales Tax.

Not Accepted:

- Wholesale (Buy-Sell) Items
- Manufactured Kits
- On-site Production
- Nudity
- Produce
- Food
- Live Plants



Vendor Fees: Upon acceptance as a vendor, fees must be paid by the Wednesday preceding weekend in order to guarantee a space reservation. Vendor fees are \$30 (\$32.71 plus tax) per single day or \$107(\$100 plus tax) for four days. Days do not have to be consecutive. One change per 4 week block will be permitted without penalty. This is a rain or shine event.

Reservations: The Market Managers will request confirmation of vendor participation for the following weekend on Sunday evenings. Confirmation of participation will need to be provided to the market manager by 12:00pm on Wednesday.

Space Assignments: There are tent spaces and table/umbrella spaces available. Stock or additional personal items may not be stored outside the tent on the street side. Vendor space assignments will be made by the market manager on Fridays.

Set Up: The event's hours are 9:00am – 2:00pm each Saturday, Sunday, in-season Fridays and specified holiday Mondays. Set up begins at 8:00am and must be completed by 9:00am. Tear down begins at 2:00pm with all vendors clearing the patio by 3:00pm.

Spaces: The space is 10' x 10' for a tent or open display area and 8' x 4' for a table/umbrella. You will not be permitted to exceed your space as there are no walkways between tents. Your table or display must be neat and professional in appearance. Set up is on pavement, so weights are required to secure your tent and display as the area is very windy. One artist per space is permitted. An additional \$20 fee must be paid to Suntan if two artists will be exhibiting in a single space.

Sales Tax: All vendors must submit a copy of their current Florida Dept. of Revenue Resale Certificate prior to vending for the first time. Vendors are responsible for the collection of all applicable sales tax and must report directly to the Florida DOR. Information is available on-line at myflorida.com. Conduct: You are responsible for cleaning up your area at the end of the day. Each vendor is expected to conduct themselves in a courteous and professional manner.
